Noted during discussion on upcoming trial:

The Coordinating Committee originally received communication from the ad-hoc O.J.B. committee indicating:

- a) that charges numbered one (1) through three (3) (of six originally filed) were found to be with merit and
- b) that efforts to resolve the matter short of trial were not successful.

The ad-hoc O.J.B. committee also recommended, "to table or withhold any further action against those charged pending the completion of the General Synod's dialogue."

After significant discussion the Coordinating Committee in light of Book of Church Order 2.I.4.6, made a motion, seconded, carried, to proceed to trial.

Contract with Rich Schuler The following contract for consulting services with Rich Schuler for follow-up with the Church Health Assessment process was approved by the Coordinating Committee: The Classis of Chicago contracts with Rich Schuler as a consultant to lead the Classis efforts at follow-up and implementation of the Church Health Assessment reports. The contract shall run from January 1- December 31, 2008. The total compensation shall not exceed \$35,000, and shall be disbursed monthly. The Consultant is to work, in conjunction with the Church Care Committee, with the churches of the Classis to implement the recommendations contained in their respective Health Assessment reports. Additionally, the Consultant shall form an intercessory prayer team and shall communicate specific prayer requests to this team on a

regular basis. The Consultant is accountable to the Classis through the Coordinating Committee, and shall provide regular reports to the Coordinating Committee at its meetings prior to the stated sessions of the Classis. The Coordinating Committee shall evaluate the Consultant at least quarterly. Either party may terminate this contract at any time.
